Dear Disclosure Department:

I am regarding to my account [REDACTED] and my husband's account (Eric Grab [REDACTED]). As I have already documented in previous complaint letters that I have sent to FTB Executive Staff and Board of Directors over the years, on July 9, 2014, Carrey Burton- Beilby told me to send FTB more money than the amount that was due per the bill that FTB had issued. On May 17, 2016, a male FTB employee also ordered me to send FTB more money than was due per the bill that FTB had issued. In both cases, FTB falsified their internal accounting records to make it appear that the amount that I was told to send was the correct amount of money that was due.

I am writing to request information on these two employees so that I can file formal criminal charges against them.

Both of these calls were placed into the notes on my account, so you should be able to locate both employees by pulling up my account notes, finding the specific entries for the two dates in question, and identifying which employee made the notes.

I am requesting disclosure of Ms. Burton- Beilby's employee number, her job title on July 9, 2014, her job title now, and whether or not she had an oath of office at that point in time. If she did have an oath of office, I would like you to provide this oath.

I am also requesting the full name and the employee number of the gentlemen who assisted me on May 17, 2016, along with his job title on May 17, 2016, his job title now, and whether or not he had an oath of office at that point in time. If he did have an oath of office, I would like you to provide this oath.

Since this is a *bona-fide* criminal matter, failure to provide this information will be considered collusion to cover up criminal activities, and I will instead file collusion charges against Dennis Haase and Grace LeBleu.

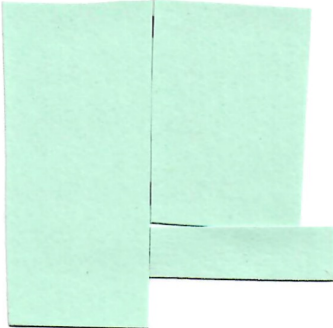
