Dear Public Records Department:

On June 19, 2022, I mailed a California Public Records Act (PRA), Government Code section 7920.000, et seq. I had included a check for \$1.00, as I had been instructed to by the woman I had spoke with when I had called to find out how to order the copy of the oaths. On August 15, 2023, I called to follow up on the request. The person I spoke with said that the normal processing time was two-weeks, so the request had likely not been received. He had me leave a message for Juan T. Unfortunately, Juan's voicemail hung up on me. I tried again to leave a message, and it hung up on me again. So today I am trying again to make this request.

My understanding is that, per 28 U.S. Code § 453, all judges in the United States are required to take an Oath of Office prior to beginning service.

My understanding is that every State of California employee must sign STD 689, Oath of Allegiance before beginning the duties of their employment (Government Code sections 1360, 1362-1369 and Section 3 of Article XX of the Constitution of California).

I request a copy of both of these oaths, the Oath of Office and the Oath of Allegiance, for the Honorable Eddie C. Sturgeon, who is a San Diego Superior Court judge in Department C-67. This time, I have enclosed two \$1 checks in case the reason the last request wasn't processed was because you needed \$1 for each of the oaths.
