Under the general direction of the Executive Officer, the Chief Counsel is responsible for advising the Executive Officer and Senior Management on a variety of legal matters, and formulates, recommends and implements departmental legal policies with respect to the California Personal income Tax Law, Bank and Corporation Tax Law, Taxpayer Bill of Rights, Homeowner's and Renter's Assistance Law, Political Reform Audit Law, and state civil service and personnel laws. The Chief Counsel also plans, organizes and directs the management of the Legal Division, which is comprised of approximately 126 employees.

35%	Advises Executive and Senior management on a variety of legal matters, and formulates, recommends and implements departmental legal policies with respect to the California Personal Income Tax Law, the Corporation Tax Law, Taxpayer Bill of Rights, Homeowner's and Renter's Assistance Law, and the Political Reform Audit Law. As a member of the department's senior management team, participates in policy decisions affecting all areas of the department and its operations; identifies potential legal problems and recommends policies and solutions.
25%	Provides direct advice on policy development, recommendations and implementation to the Executive Officer and senior management, and recommends effective strategies to achieve legislatively or legally mandated objectives.
20%	Represents the Franchise Tax Board before the Legislature and its committees, other government entities, including the Attorney General's Office and the three-member Franchise Tax Board, and represents the State in litigation cases and issues involving taxpayers and/or their representatives.
20%	Plans, organizes and directs the activities of staff in the Legal Division who are involved in: interpreting laws, regulations and court decisions; handling taxpayer protests and appeals; representing the department before various state administrative bodies including the State Board of Equalization and the State Personnel Board; acting as liaison with the Office of the Attorney General in litigation; testifying before legislative and congressional committees; drafting and analyzing bills; promulgating regulations; and rendering advice with regard to personnel,

collection, investigation and other administrative matters.
