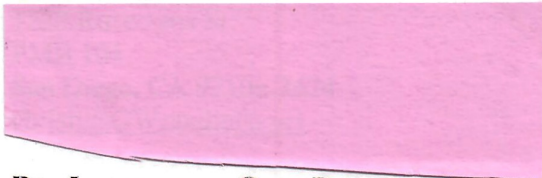

RE: LEGISLATIVE OPEN RECORDS ACT REQUEST

Dear Ms. Grab:
