Dear State Senate:

On December 3, I made a LORA request: <https://gwsandiego.net/blog/wp-content/uploads/2024/12/Dec-3-Senate-LORA-Request-and-confirmation-of-receipt.pdf>

The response was due on the 17th. Erika Contreras did not respond.

I left a message for both John Nam and Erika Contreras yesterday to follow up. I got no call back, nor did they provide the LORA response.

It appears that the State Senate is doubling down on its unlawful schemes to evade federal and state laws. While it may not be the State Senate’s protocol, I would strongly suggest that the people on the list linked above send me your oaths and bonds directly. You are each responsible for yourselves. Please protect yourself by proving you are lawfully employed — staying complicit is supporting Erika Contreras’s unlawful behavior, and it could land you in prison as working without an oath is a federal felony — it is up to YOU to prove you have a compliant oath in place.

Dear State Senate:

This is a reminder that, even if all the legislators took oaths for 2025, it doesn't change the fact that all legislative work done by legislators in previous sessions of congress who did not have a current oath in place for that session must be voided. One more person to add to the list of legislators whose work needs to be voided is Joqauin Arambula, who did not file an oath with the SOS for 2017 – 2018, 2019 – 2020 or for 2023 – 2024. I realize that Mr. Arambula is an assemblyman, but the work of the assembly being voided directly affects the senate.

This is also a reminder that the LORA request that I made on December 3, 2024 is due tomorrow. I expect the State Senate to fully comply with the LORA laws and the Brown Act by providing the requested documents unredacted. "We the people" are your employers and it is our responsibility to make sure that our employees are working in accordance with the law.

Finally, this is also a reminder that YOU are responsible for YOURSELF. It is up you YOU to make sure that you have an oath and bond filed with the SOS. YOU are the ones who will face prosecution if you don't. The argument that the State Senate told you that you didn't need them is not going to hold up in court.

I hope that the criminal conspiracy to evade the oath and bond laws that has been perpetrated by the State Senate has been halted and all State Senate employees are now lawfully employed.
