Dear State Senate:

Just another reminder that the State Senate has been knowingly and intentionally allowing Scott Wiener to commit fraud by falsely posing as a State Senator. Without a current oath filed with the Secretary of State, he did not have legal standing to be working as a legislator.

By failing to sign an oath when this was brought to his attention in January 2024, but continuing work unlawfully, Mr. Wiener has been acting as *a foreign agent posing as a government agent* and subject to prosecution under US Criminal Code Title 18 U.S.C. § 912, which is punishable with up to three-years in federal prison. This falls under the purview of both the federal government and the military.

The people within the State Senate who have knowingly allowed Mr. Wiener to continue working fraudulently, along with those who attempted to cover up Mr. Wiener's fraud, are all co-conspirators.

Based on my interaction with the State Senate, I believe that the Senate staff that I have contacted have all been smug that they could get away with violating the laws documented in the links above. My assumption is that the smugness came from knowing that Rob Bonta nor the Biden administration would prosecute. But the Trump administration may prosecute. There is no statute of limitations on fraud.

Please, correct the crimes the State Senate intentionally committed against the constituents by immediately vacating Wiener from office and voiding all of the legislative work done since Wiener's oath expired at the end of 2018. Correcting these legal violations shows your constituents that you are acting in good faith to lawfully serve the people. By failing to correct these legal violations, you are subjecting yourself to prosecution.

Furthermore, please void all legislative work done by Bradford, Caballero, Durazo, Grove, Laird, Rubio, Skinner and Talamantes Eggman for the periods where there was a lapse in their oaths (details and links to the oaths are below in this thread, dated November 12).

Moving forward, please show the constituents that the State Senate understands that they are not above the law. Please make sure that all State Senate legislators and staffers have current oaths that comply with the laws and surety bonds filed with the Secretary of State (the laws are cited in the documents linked above).

Hello State Senate:

This is another reminder that "we the people" — your employers — will no longer tolerate State Senate employees brazenly violating federal and state laws by failing to keep oaths compliant with federal and state laws and by failing to procure surety bonds.

As I documented in the *Notice of Legal Violations*, the *Writ of Quo Warranto* and the *Certificate of Default* ([part 1](#), [part 2](#)), I have been asking Wiener to sign a current oath since January of this year. Wiener has failed to do so, yet continued to work as a legislator while knowing full well that he was working unlawfully.

It is no surprise that Mr. Wiener has made the choice to risk prison rather than promise to uphold the constitutions. After all, Mr. Wiener aggressively pushes legislation that protects perpetrators and leaves victims more vulnerable, such as decriminalizing purchasing an infant prostitute as long as the "John" is 17 or younger (alterations made to SB-1414 by the Public Safety Committee). Child prostitution is a violation of the 13th amendment no matter what age the "John" may be, so in this case, Wiener was intentionally creating a law that violated the constitution.

I have also documented that Wiener's entire staff have conspired together to aid Wiener to commit this felony, and that multiple staff members also tried to cover up his crimes via fraud. Wiener's staff have made it clear that they believe that that laws don't apply to Wiener — or to themselves, as *prima fascia* indicates that the majority of Wiener's staff are also working unlawfully without current, proper oaths or bonds.
