Dear State Senate:

This is a reminder that Mr. Wiener was unlawfully working as a foreign agent posing as a government agent from 2019 - 2024, Since he was fraudulently occupying this position, he had no legal standing nor jurisdiction. Fraud vitiates everything it touches; all of Mr. Wiener's legislative work must be voided, including bills he authored, co-authored, sponsored, legislative changes made on committees and all votes he cast.

Furthermore, there have been several other people caught fraudulently occupying senate seats without (then) current oaths filed with the Secretary of State. All legislative work must be voided for the following people for the dates noted:

Bradford, Steven: No oaths for 2019 – 2020 or 2022 – 2024

Caballero, Anna: Was an assemblyman from 2006 – 2010 and from 2016 – 2018. She did not take an oath for either assembly term.

Durazo, Maria Elena: No oath for 2021 – 2022.

Grove, Shannon: No oaths for 2015 – 2016 (Assembly) or 2017 – 2018 or 2021 – 2022 (Senate)

Laird, John: No oath for 2023- 2024; no bond.

Rubio, Susan: No oath for 2021 – 2022;

Skinner, Nancy: No oath for 2023 – 2024 nor 2019 – 2020

Talamantes Eggman, Susan: No oath for 2013 – 2014 or 2023 – 2024

"We the people" are your employers. As your employers, we expect the State Senate to comply with federal and state laws by immediately voiding the legislative work of the people referenced above.

Dear State Senate Employees:

This is a reminder that you are each responsible for yourselves.

I have documented that Erika Contreras, John Nam, Lynne Cervinka and Sheila Braverman have been criminally conspiring to evade the federal and state oath/bond laws. This failure by leadership to comply with laws does not absolve each of you of your personal responsibility to have a current, fully executed oath that complies with the constitutional requirements and a surety bond filed with the Secretary of State.

YOU are the one who will go to prison if the Trump administration and/or the military chooses to prosecute these crimes. The argument that leadership told you the expired oath was still valid and that surety bonds aren't required won't hold up in court -- especially since I have repeatedly shown you all the pertinent laws and the State Senate has not denied that my interpretation of the laws is correct.

I realize that no one has been prosecuted to date for failure to comply with oath/bond laws. However, since the election, the California governor and many legislators -- including Scott Wiener -- have been boldly proclaiming that federal laws/rules do not apply to California. These people have basically dared Trump and the military to go after them. It will not surprise me if Trump accepts that dare.

I strongly recommend that each one of you do what you need to do to ensure that you are lawfully employed (and thus not caught up in the cross-fire).
