Oaths are required by federal law. You all know that President Trump will not hesitate to prosecute you all for oath violations. Please, protect yourselves by proving you are lawfully employed. Take it upon yourself to break protocol and send your oath to me. Do not go down with the sinking ship!

Even if I notify the Trump administration and it turns out this was a msitale and that you did have oaths on file with the SOS, **you still have all conspired together to violate the LORA laws** by not timely providing the oaths.
