Hello,

Today I received a letter from the SOS stating that not a single person at the State Senate has filed an oath or bond for the 2025 - 2026 session.

I hope this is some kind of mistake. However, given that the State Senate has violated the LORA laws by not providing the oaths/bonds (or at least a date the oaths/bonds would be produced), given the fact that none of you have taken the initiative to send your oaths to me when you knew I hadn't gotten them from the State Senate, and given the fact that people at Scott Wiener's office literally laughed at me and slammed the phone down when I called and asked if it was a mistake, it certainly looks to me like each of you are intentionally conspiring together to commit the felony of working without an oath — not having an oath is one count and conspiracy is a second count.

Why does everyone hate the government? Because we are your employers. We pay your salaries. It is our responsibility as your employers to make sure that you are lawfully employed. And instead of simply signing a piece of paper and sending over a copy of that piece of paper, you try to ignore us, treat us like dirt and mock us for asking you to follow the laws. We are done with "rules for thee, but not for me."

If this is a mistake, please send over those oaths that have been stamped as filed immediately.

This is a reminder that the response to the LORA request for copies of each of your oaths and

This is a reminder that the response to the LORA request for copies of each of your oaths and bonds is now a full two months past due. The law states that you must respond within two weeks, and if you are not able to fulfill the request in that period, you have to give a reason why and the date that the request will be completed. John Nam has failed to provide a reason for the delay nor a date to expect the response.

This is a trick. Mr. Nam knows that he cannot legally deny my request, so instead he is going to have it “in-process” forever — which is essentially the same thing as a denial. It is frustrating that Mr. Nam is willfully violating the law and that Erika Contreras, Eleni Kounalakis, Mike McGuire, Sheila Braverman, Lynne Cervinka all support and protect this brazen violation of the law.

At this point, it is clear that the reason Mr. Nam has failed to provide oaths and bonds is because the State Senate Secretary and HR has yet again failed to properly do their jobs by ensuring that everyone is lawfully employed.

While they may have failed to do their jobs, each one of you is responsible for yourselves — you are the one committing a felony if you do not ensure that you have an oath filed with the Secretary of State. You are the one subject to immediate termination if you do not have a bond filed with the Secretary of State.

Since Mr. Nam is brazenly violating the law, it is up to each one of you to prove to me and the 500 others in my army that you are compliant with the laws. Please, if you have an oath and bond in place, please send them over to me. Failure to do so makes you a co-conspirator in the criminal scheme to evade the federal and state oath and bond laws. Not responding to the LORA request is a misdemeanor. Conspiracy to commit a misdemeanor (each one of you also failing to respond to the request) is a felony.

Dear State Senate:

This is a reminder that anyone who works for the government in any capacity is required by federal and state laws to prove that you have a properly executed oath and a bond filed with the Secretary of State.

Failure to comply with the oath requirements is a felony punishable with up to three-years in prison.

The LORA request that I made for copies of each of your oaths and bonds is now 5-weeks past due. Since you have not provided proof of lawful employment, “we the people” == who are your employers — can only assume that you are each knowingly and intentionally committing the felony of working unlawfully.

If you have an oath and bond in place, please send it over immediately. If I do not receive the oaths and bonds soon, there will be consequences, as “we the people” have the right
